BELL COUNTY MENTAL HEALTH COURT AND SOCIAL WORK PROGRAM

Bell County started a Mental Health Court and Social Work Program in April 2011 with a grant from the Texas Indigent Defense Commission. There are three different moving parts with this program. This is really important piece.

The Bell County Mental Health Indigent Defense Program's primary purpose is to assess clients who are identified as having a mental health diagnosis when they are arrested and fill in the gaps that exist in their network of mental health and social services. In addition to networking them to services, we provide case management services throughout their time on the status docket. We communicate, and work with, their defense attorneys on establishing and assisting clients meet goals in order to increase their chance of long-term success. In short, this team approach during docket has proven benefits in lowering the recidivism rate within this population. Although we primarily service clients in the Bell County area, we do work with clients out of the area as well. Typically, our program interfaces with Central Counties Services for mental health and intellectual developmental disability assessment, diagnosis and treatment. We have long-standing relationships with several substance abuse treatment facilities, free clinics, transportation services, housing accommodations, employment assistance agencies, indigent health care coverage office and other health/ counseling service centers.

SAME CHARGE...DIFFERENT BOND

Have you ever wondered how two people charged with the same crime, in the same jurisdiction, receives a different bond?...Or how two people that are codefendants on a crime could possibly have differing bond amounts set?... And when either of these situations occurs, are they an indicator of a flawed or injustice system?

Within local jurisdictions, Pretrial Services has the responsibility of assessing-risk and making bond recommendations in adult criminal matters. Pretrial Services' bond recommendations are based on the basic premises of the Bail Reform Act of 1966 and the Bail Reform Act of 1984. The Bail Reform Act of 1966 focuses on the assurance that a defendant will return to court for future hearings, if released on a bond. The Bail Reform Act of 1984 focuses on the potential danger a defendant poses to the community, if released on a bond.

As recommended in the Essential Elements of an Effective Pretrial System and Agency (2017), pretrial services systems should use evidence-based objective risk tools to inform the release decision. In general, pretrial risk tools can reasonable predict the defendant's future appearance probability and their threat to the community. On July 29, 2017 Harris County Pretrial Services implemented the Public Safety Assessment (PSA) risk tool offered by the Laura and John Arnold Foundation. The PSA has nine (9) risk factors that can be objectively scored. The risk factors include:

- 1) Age at current arrest
- 2) Current Violent Offense
- 3) Pending Charge at the time of the offense
- 4) Prior misdemeanor conviction
- 5) Prior felony conviction
- 6) Prior violent conviction
- 7) Prior failure to appear in the past two years
- 8) Prior failure to appear older than two years
- 9) Prior sentence to incarceration

Once a defendant's risk score is totaled, there are three (3) risk indicators:

- New violent criminal flag is triggered based on a set threshold.
- Failure to appear (FTA) score ranges from one (1) to six (6).
- New criminal activity (NCA) score ranging from one (1) to six (6).

On both the FTA and NCA respective scales, a defendant's risk is classified as low (1-2), average (3-4), or high (5-6). Generally, a low risk defendant may have limited to no release conditions in their bond. An average risk defendant may have release conditions to mitigate their risk. For a high risk defendant, there are no conditions or combination of conditions that can assure community safety or appearance in court.

Utilizing a validated risk assessment tool provides an objective means to assess each individual defendant's risk. In the United States Supreme Court case, Stack v. Boyle, twelve individuals were charged with conspiracy in federal court. At the bail hearing, the district judge set bond in the amount of \$50,000 for all twelve defendants, despite evidence of their differing financial resources, family ties, health, and criminal records. It was determined that this was a violation of their Eighth Amendment rights, in that a defendant has a right to bond that is based on their individual risk factors. And thus, two defendants with the same charge, in the same jurisdiction, can receive a different bond based on their respective risk scores. Also, two co-defendants on the same crime could possibly have different bond amounts set based on their individual risk scores.
